In accordance with General Condition 20 of the FTNS Licence, PCCW-HKT Telephone Company Limited ('the Company') hereby publishes the tariffs, the terms and conditions under which it will provide the following telecommunications services.

Conditions of Service

1. This service is subject to the General Conditions of Service of the Company. Special Conditions of Service of the New Generation Business Fixed Lines applies to customers subscribing New Gen Business DEL service, New Gen Citinet service, New Gen Hunting service.
2. Customer shall commit to subscribing the Business Line for 12 months ('Term Plan').
3. Customer, who changes the application of external relocation and new line installation to external relocation only or new line installation only for any reason, is not eligible to subscribe to this Term Plan offer.
4. The offer is not applicable to business lines that are enjoying any other term plan or other form of line rental rebate/waiver.
5. Each registered customer account can register this Term Plan for not more than 20 lines.
6. Each line is eligible for a rebate of External Relocation Charge and New Line Installation Charge once throughout the 12-month commitment period.
7. External Relocation Charge and New Line Installation Charge will be rebated to customer only if the external relocation and new line installation is completed within one month after the application date of this Term Plan.
8. Term Plan is effective upon external relocation and new line installation is completed.
9. Customer shall pay External Relocation Charge and New Line Installation Charge and Business Line rental in full at standard tariffs in advance quarterly. A one-off rebate of External Relocation Charge and New Line Installation Charge will be credited to customer in the next following bill.

10. If a customer terminates the Term Plan or Business Line or changes the registered name of the relevant Business Line before the end of the Term Plan,
 - (a) the customer has to pay an early termination charge to the Company, which is calculated by multiplying the basic monthly rental by the remaining months of the 12-month period (such termination charge will be calculated on a pro rata basis if the remaining period does not form a complete month). In the case of the termination of the Business Line, the Customer is required to give at least 30 days prior written notice to the Company.
 - (b) External Relocation Charge and New Line Installation Charge which have not yet been credited to the customer will be forfeited immediately.
11. If customer's bill payment is overdue, the rebate of External Relocation Charge and New Line Installation Charge which have not yet been credited to the customer will be forfeited immediately. In addition, the service will be terminated and the customer has to pay the early termination charge as mentioned in Condition 10(a) above.

Delivery Time of Service

Under normal circumstances, the delivery lead time is within ten days.

FIXED TELECOMMUNICATIONS NETWORK SERVICES LICENCE
TELECOMMUNICATIONS ORDINANCE (Chapter 106)

In accordance with General Condition 20 of the Fixed Telecommunications Network Services Licence, PCCW-HKT Telephone Limited (the Company) hereby publishes the Tariff Schedule comprising the tariffs, the terms and conditions under which it will provide the following telecommunication services with effect from 5th October 2004.

1. Item 8(b)(ii) of Part VI of the Tariff Schedule is amended by adding '10% of charges of Call In' immediately after 'Infifax'.

3. Customer, who changes the application of 2 or above new line installation to less than 2 new line installation for any reason, is not eligible to subscribe to this Term Plan offer.
4. The offer is not applicable to business lines that are enjoying any other term plan or other form of line rental rebate/waiver.
5. Each registered customer account can register this Term Plan for not more than 20 lines.
6. Customer should subscribe 2 or above new lines in the same application to enjoy the Term Plan.
7. New Line Installation Charge will be credited in form of rebate to customer only if the new installation is completed within one month after the application date of this Term Plan.
8. Term Plan is effective upon new line installation is completed.
9. Customer shall pay New Line Installation Charge and Business Line rental in full at standard tariffs in advance quarterly. A one-off rebate of New Line Installation Charge will be credited to customer in the next following bill.
10. If a customer terminates the Term Plan or Business Line or changes the registered name of the relevant business line before the end of the Term Plan,
 - (a) the customer has to pay an early termination charge to the Company, which is calculated by multiplying the basic monthly rental by the remaining months of the 12-month period (such termination charge will be calculated on a pro rata basis if the remaining period does not form a complete month). In the case of the termination of the Business Line, the Customer is required to give at least 30 days prior written notice to the Company.
 - (b) New Line Installation Charge which has not yet been credited to the customer will be forfeited immediately.
11. If customer's bill payment is overdue, New Line Installation Charge which has not yet been credited to the customer will be forfeited immediately. In addition, the service will be terminated and the customer has to pay the early termination charge as mentioned in Condition 10(a) above.

TELECOMMUNICATIONS ORDINANCE (Chapter 106)

In accordance with General Condition 20 of the FTNS Licence, PCCW-HKT Telephone Limited (the Company) hereby publishes revision to tariffs of the following services.

With effective from 6th October 2004, for Gazette No. 41/2004 on 8th October 2004

1. Residential Direct Exchange Line (RDEL) – 9-Month Term Plan with Loyalty Gift
 - Replace the offer period ‘29th September to 5th October 2004’ with ‘6th to 12th October 2004’

2. Residential Direct Exchange Line (RDEL) – 9-Month Term Plan (\$20 rental refund)
 - Replace the offer period ‘29th September to 5th October 2004’ with ‘6th to 12th October 2004’
 - Replace Item 1 of Note 1 with ‘If the Customer terminates the Term Plan or RDEL or changes the registered name of that line prior to the expiry of the commitment period, the rental refund for the remaining months of the commitment period will be forfeited and the unlimited relocation fee waiver will no longer be applicable from the date of termination. In addition, Customer will be required to pay the RDEL line rental for the remaining period of commitment period on pro rata basis at the amount of \$110 per month. In the case of the termination of the RDEL, the Customer is required to give at least 30 days prior written notice to the Company.’
