

## 申請限用無線電話資格證書(長距離)／(短距離)及操作授權證明／操作授權證明續期 Application for Restricted Certificate of Competency in Radiotelephony (Long Range) / (Short Range) and Authority To Operate (ATO) / ATO Renewal

填寫本表格前，請你閱讀以下資料。限用無線電話資格證書(長距離)／(短距離) 及操作授權證明申請指引刊載於通訊事務管理局辦公室(通訊辦) 網頁(<http://www.ofca.gov.hk>)。

1. 通過相關認可訓練課程考試的人士可申請獲發限用無線電話資格證書(長距離)/(短距離)及操作授權證明在非SOLAS船隻上操作GMDSS器材。
2. **有關證書及操作授權證明申請：**
  - (a) 申請時需要提交以下文件：
    - (i) 兩張相同的個人近照（照片必須在申請日期前六個月內拍攝，而大小約為 40 x 50 毫米）；
    - (ii) 護照或香港身份證；
    - (iii) 通過相關認可訓練課程考試的證明文件；及
    - (iv) 由申請人簽署的《使用無線電通訊裝置的保密聲明》（保密聲明）。
  - (b) 簽發證書費用為港幣120元，而操作授權證明簽註費用為港幣160元（合共港幣280元）。
3. **有關操作授權證明續期申請：**
  - (a) 申請時需要提交以下文件：
    - (i) 護照或香港身份證；及
    - (ii) 現有的限用無線電話資格證書(長距離)／(短距離)及操作授權證明。
  - (b) 續期的費用為港幣160元。
4. **有關證書複本申請：**
  - (a) 申請時需要提交以下文件：
    - (i) 兩張相同的個人近照（照片必須在申請日期前六個月內拍攝，而大小約為 40 x 50 毫米）；及
    - (ii) 護照或香港身份證。
  - (b) 申請複本的費用為港幣55元。
5. 如未能呈交所有文件，申請將**不獲**處理。
6. 填妥的申請表格，請以下列方式提交：

7. 所需證明文件，請以下列方式提交：
  - (a) 如親自前往通訊辦支援服務分組，申請人須提交有關文件的正本和副本或已由簽發機構或公證人證明為真確的有關文件副本供通訊辦辦理；或
  - (b) 如郵寄至通訊辦支援服務分組，申請人須提交已由簽發機構或公證人證明為真確的有關文件副本及已填妥的保密聲明。保密聲明（表格編號 OFCA F226）可於通訊辦網頁 (<http://www.ofca.gov.hk>) 下載。
8. 接受現金、支票或匯票付款。支票或匯票抬頭人請註明為『通訊事務管理局辦公室』。支票須劃線。若採用海外支票或匯票繳費，申請人須負責本地銀行收取的額外手續費。付款辦法 -
  - (a) 如親自前往通訊辦支援服務分組，接受以現金、劃線支票或匯票付款；或
  - (b) 如經互聯網、郵遞、傳真或電郵提交申請表格，可郵寄劃線支票或匯票至通訊辦支援服務分組收。如必須以匯款付款，請聯絡通訊辦支援服務分組以作特別安排。
9. 辦公時間為星期一至五上午八時三十分至下午十二時三十分及下午一時三十分至下午五時四十五分。星期六、日及公眾假期休息。

The "Guidelines on Application for Restricted Certificate of Competency in Radiotelephony (Long Range)/(Short Range) and Authority To Operate (ATO)" is published at the Office of the Communications Authority's (OFCA's) website (<http://www.ofca.gov.hk>).

1. Person passing the examination of the relevant recognized training course can apply for Restricted Certificate of Competency in Radiotelephony (Long Range)/(Short Range) (LRC/SRC) and Authority To Operate (ATO) to operate GMDSS equipment onboard non-SOLAS ships.
2. **For Certificate and ATO Application:**
  - (a) The following documents are required to support this application:
    - (i) 2 identical recent photographs (approx. 40mm x 50mm and should be taken within 6 months prior to the application date);
    - (ii) passport or Hong Kong Identity Card;
    - (iii) evidence of passing an approved Restricted Certificate of Competency in Radiotelephony (Long Range)/(Short Range) training course;

AND

    - (iv) "Declaration of Secrecy in the Operation of Radiocommunications Apparatus" (Declaration of Secrecy) duly signed by the applicant.
  - (b) The issue fee for a LRC/SRC is HK\$120 and that for the ATO is HK\$160 (totally HK\$280).
3. **For ATO Renewal Application:**
  - (a) The following documents are required to support this application:
    - (i) passport or Hong Kong Identity Card; AND
    - (ii) current LRC/SRC and ATO.
  - (b) The ATO renewal fee is HK\$160.
4. **For Duplicate Certificate Application:**
  - (a) The following documents are required to support this application:
    - (i) 2 identical recent photographs (approx. 40mm x 50mm and should be taken within 6 months prior to the application date); AND
    - (ii) passport or Hong Kong Identity Card.
  - (b) The issue fee for a duplicate certificate is HK\$55.
5. Application with insufficient supporting document will **not** be processed.
6. Please submit the completed application form by any of the following methods:

7. Please submit the supporting documents by any of the following methods:
  - (a) In person to Support Services Sub-section of OFCA. Applicant should submit the originals and photocopies of the relevant documents or the photocopies of the relevant documents which are certified true by the issuing authority or notary public for processing. For ATO renewal, the applicant should submit the original copy of the current LRC/SRC for processing; OR
  - (b) By post to Support Services Sub-section of OFCA. Applicant should submit the photocopies of the relevant documents and a duly completed Declaration of Secrecy. These documents should be certified true by the issuing authority or notary public. The Declaration of Secrecy (Form No. OFCA F226) could be downloaded from OFCA's website (<http://www.ofca.gov.hk>). For ATO renewal, the applicant should submit the original copy of the current LRC/SRC for processing.
8. Payment can be made by cash, cheque or bank draft. Cheque or bank draft should be made payable to "Office of the Communications Authority" and cheque should be crossed. Overseas cheque or bank draft should include any additional charges incurred by our local banks.
