

申請通用／限用值機員證書及簽註和證書延續簽註 Application for General / Restricted Operator's Certificate (GOC/ROC) and Endorsement and Certificate Endorsement Revalidation

 - (iv) 由申請人簽署的《使用無線電通訊裝置的保密聲明》（保密聲明）；
 - (v) 海員健康證明書；
 - (vi) STCW守則第 A-VI/1-1至A-VI/1-4部分附屬規定的認可基本訓練或指導的證明（STCW 規定下所頒發的基本培訓證書或由香港特別行政區政府簽發的有效甲板高級船員或輪機師的合格證書或執照可接納作為已接受有關訓練或指導的證明）；及
 - (vii) 任何其他適用的補充文件。
 - (b) 簽發證書費用為港幣410元，而證書簽註費用為港幣160元（合共港幣570元）。
3. 有關證書延續簽註申請 -
 - (a) 申請時需要提交以下文件 -
 - (i) 護照或香港身份證；
 - (ii) 海員健康證明書；
 - (iii) STCW守則第 A-VI/1-1至A-VI/1-4部分附屬規定的認可基本訓練或指導的證明（STCW 規定下所頒發的基本培訓證書或由香港特別行政區政府簽發的有效甲板高級船員或輪機師的合格證書或執照可接納作為已接受有關訓練或指導的證明）；
 - (iv) 海員辭職證書、海員服務紀錄簿或海員僱用登記簿；及
 - (v) 現有的通用／限用值機員證書與證書簽註。
 - (b) 延續簽註的費用為港幣160元。
4. 有關證書申請 -
 - (a) 申請時需要提交以下文件 -
 - (i) 兩張相同的個人近照（照片必須在申請日期前六個月內拍攝，而大小約為 40 x 50 毫米）；
 - (ii) 護照或香港身份證；
 - (iii) 由通訊局認可之院校所簽發的成績單或證書；及
 - (iv) 由申請人簽署的《使用無線電通訊裝置的保密聲明》（保密聲明）。
 - (b) 簽發證書費用為港幣410元。
5. 有關證書複本申請 -

6. 如未能呈交所需文件，申請將不獲處理。

9. 接受以現金、劃線支票、銀行本票、「繳費靈」、「易辦事」、「轉數快」繳費櫃檯付款。劃線支票或銀行本票須註明支付「通訊事務管理局辦公室」。若採用海外支票或銀行本票應包括本地銀行收取的手續費。付款辦法 -

Please read the information below and the “Guidelines for the Issue of STCW GMDSS Radio Certificate of Competency with Endorsement and Certificate Endorsement Revalidation” in the Office of the Communications Authority’s (OFCA’s) website (<http://www.ofca.gov.hk>) before completing this form.

1. In accordance with Regulations I/2, I/10 and I/11 of the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers (STCW), 1978, as amended and Hong Kong legislation, a seafarer manning a radio station on a Hong Kong registered ship has to hold an appropriate Hong Kong issued GMDSS radio certificate and endorsement in conformity with the requirements of the STCW Convention currently in force.
2. For Certificate with Endorsement Application -
 - (a) The following documents are required to support this application -
 - (i) 2 identical recent photographs (approx. 40mm x 50mm and should be taken within 6 months prior to the application date);
 - (ii) passport or Hong Kong Identity Card;
 - (iii) the result slip or certificate issued by the institutes recognised by the Communications Authority (CA);
 - (iv) “Declaration of Secrecy in the Operation of Radiocommunications Apparatus” (Declaration of Secrecy) duly signed by the applicant;
 - (v) medical fitness certificate;
 - (vi) evidence of having received approved basic training or instruction in the ancillary requirements of the STCW Code Section : A-VI/1-1 to A-VI/1-4 (basic training certificates issued under the provisions of the STCW or a valid Certificate of Competency or licence as Deck Officer or Marine Engineer Officer issued by the Hong Kong Administration can be accepted as evidence of having received such training or instruction); AND
 - (vii) any other additional documents whichever applicable.
 - (b) The fee for the issue of a GOC/ROC is HK\$410 and that for the Endorsement is HK\$160 (i.e. a total of HK\$570).
3. For Certificate Endorsement Revalidation Application -
 - (a) The following documents are required to support this application -
 - (i) passport or Hong Kong Identity Card;
 - (ii) medical fitness certificate;
 - (iii) evidence of having received approved basic training or instruction in the ancillary requirements of the STCW Code Section : A-VI/1-1 to A-VI/1-4 (basic training certificates issued under the provisions of the STCW or a valid Certificate of Competency or licence as Deck Officer or Marine Engineer Officer issued by the Hong Kong Administration can be accepted as evidence of having received such training or instruction);
 - (iv) seaman’s discharge book, seaman’s service record book or seafarer’s employment registration book; AND
 - (v) current GOC/ROC with certificate endorsement.
 - (b) The endorsement revalidation fee is HK\$160.
4. For Certificate Application -
 - (a) The following documents are required to support this application -
 - (i) 2 identical recent photographs (approx. 40mm x 50mm and should be taken within 6 months prior to the application date);
 - (ii) passport or Hong Kong Identity Card;
 - (iii) the result slip or certificate issued by the institutes recognised by CA; AND
 - (iv) “Declaration of Secrecy in the Operation of Radiocommunications Apparatus” (Declaration of Secrecy) duly signed by the applicant;
 - (b) The fee for the issue of a GOC/ROC is HK\$410.
5. For Duplicate Certificate Application -
 - (a) The following documents are required to support this application -
 - (i) 2 identical recent photographs (approx. 40mm x 50mm and should be taken within 6 months prior to the application date);
 - (ii) passport or Hong Kong Identity Card; AND
 - (iii) written confirmation of the loss of certificate.
 - (b) The fee for the issue fee of a duplicate certificate is HK\$55.
6. Application with insufficient supporting document will not be processed.
