 - (a) 申請時需要提交以下文件 -
 - (i) 兩張相同的個人近照(照片必須在申請日期前六個月內拍攝，而大小約為 40 x 50 毫米)；
 - (ii) 護照或香港身份證；
 - (iii) 通過限用無線電話資格證書考試的證明文件；及
 - (iv) 由申請人簽署的《使用無線電通訊裝置的保密聲明》(保密聲明)。
 - (b) 簽發證書費用為港幣120元，而操作授權證明簽註費用為港幣160元(合共港幣280元)。
4. **有關操作授權證明續期申請** -
 - (a) 申請時需要提交以下文件 -
 - (i) 護照或香港身份證；及
 - (ii) 現有的限用無線電話資格證書及操作授權證明。
 - (b) 續期的費用為港幣160元。
5. **有關證書複本申請** -
 - (a) 申請時需要提交以下文件 -
 - (i) 兩張相同的個人近照(照片必須在申請日期前六個月內拍攝，而大小約為 40 x 50 毫米)；及
 - (ii) 護照或香港身份證。
 - (b) 申請複本費用為港幣55元。
6. 如未能呈交所有文件，申請將不獲處理。

 - (b) 如郵寄至通訊辦支援服務分組，申請人須提交已由簽發機構或公證人證明為真確的有關文件副本及已填妥的保密聲明。保密聲明(表格編號 OFCA F226)可於通訊辦網頁 (www.ofca.gov.hk) 下載。
9. 接受以現金、劃線支票、銀行本票、「繳費靈」、「易辦事」、「轉數快」繳費櫃檯付款。劃線支票或銀行本票須註明支付『通訊事務管理局辦公室』。若採用海外支票或銀行本票應包括本地銀行收取的手續費。付款辦法 -
 - (a) 如親自前往通訊辦支援服務分組，接受以現金、劃線支票、銀行本票、「易辦事」或「轉數快」繳費櫃檯付款；或
 - (b) 如經互聯網、郵遞、傳真或電郵提交申請表格，可郵寄劃線支票或銀行本票至通訊辦支援服務分組收或憑帳單編號使用「繳費靈」付款。帳單編號會於網上申請完成後以電郵通知你或在你的申請獲批准後由支援服務分組通知你。

Person passing the examination of Restricted Certificate of Competency in Radiotelephony conducted by the Office of the Communications Authority (OFCA) can apply for “**Restricted Certificate of Competency in Radiotelephony and ATO**” to operate a radiotelephone station onboard Hong Kong local vessels.
2. For Examination Application -
 - (a) The following document is required to support this application -
 - (i) passport or Hong Kong Identity Card.
 - (b) The examination fee is HK\$150.
3. For Certificate and ATO Application -
 - (a) The following documents are required to support this application -
 - (i) 2 identical recent photographs (approx. 40mm x 50mm and should be taken within 6 months prior to the application date);
 - (ii) passport or Hong Kong Identity Card;
 - (iii) evidence of passing the examination of Restricted Certificate of Competency in Radiotelephony; AND
 - (iv) “Declaration of Secrecy in the Operation of Radiocommunications Apparatus” (Declaration of Secrecy) duly signed by the applicant.
 - (b) The issue fee for the certificate is HK\$120 and that for the ATO is HK\$160 (totally HK\$280).
4. For ATO Renewal Application -
 - (a) The following documents are required to support this application -
 - (i) passport or Hong Kong Identity Card; AND
 - (ii) current Restricted Certificate of Competency in Radiotelephony and ATO;
 - (b) The ATO renewal fee is HK\$160.
5. For Duplicate Certificate Application -
 - (a) The following documents are required to support this application -
 - (i) 2 identical recent photographs (approx. 40mm x 50mm and should be taken within 6 months prior to the application date); AND
 - (ii) passport or Hong Kong Identity Card.
 - (b) The issue fee for a duplicate certificate is HK\$55.
6. Application with insufficient supporting document will not be processed.
7. Please submit the completed application form by any of the following methods -

8. Please submit the supporting documents by any of the following methods -
 - (a) In person to Support Services Subsection of OFCA. Applicant should submit the originals and photocopies of the relevant documents or the photocopies of the relevant documents which are certified true by the issuing authority or notary public for processing; OR
 - (b) By post to Support Services Subsection of OFCA. Applicant should submit the photocopies of the relevant documents and a duly completed Declaration of Secrecy. These documents should be certified true by the issuing authority or notary public. The Declaration of Secrecy (Form No. OFCA F226) could be downloaded from OFCA’s website (www.ofca.gov.hk).
9. Payment can be made by cash, crossed cheque, bank draft, PPS, EPS or FPS at counter. Crossed cheque or bank draft should be made payable to "Office of the Communications Authority". Cheque or bank draft issued by overseas bank should cover the charges of our local bank. Payment methods -
 - (a) in person to Support Services Subsection of OFCA, you may pay by cash, crossed cheque, bank draft, EPS or FPS at counter; OR
 - (b) if application is submitted online or by post, fax or email, you may send a crossed cheque or bank draft by post to Support Services Subsection of OFCA or pay by PPS using the given bill number. The bill number will be emailed to you upon online submission or notified to you by Support Services Subsection upon approval of your application.
