TELECOMMUNICATIONS ORDINANCE (Chapter 106)  
AND  
TELECOMMUNICATIONS (DETERMINING SPECTRUM UTILIZATION FEES  
BY AUCTION) REGULATION (Chapter 106AC)

By this Notice, I, in exercise of the powers conferred by section 32I of the Telecommunications Ordinance (Chapter 106) (the ‘Ordinance’) and section 10 of the Telecommunications (Determining Spectrum Utilization Fees by Auction) Regulation (Chapter 106AC) (the ‘Regulation’), specify the minimum amount of the spectrum utilization fee for the purposes of sections 5(3), 6(3) and 7(d) of the Regulation as follows:—

(1) Section 5(3) of the Regulation

The minimum amount of the spectrum utilization fee for the purpose of section 5(3) of the Regulation shall be given in the Schedule to this Notice.

(2) Section 6(3) of the Regulation

The minimum amount of the spectrum utilization fee for the purpose of section 6(3) of the Regulation shall be given in the Schedule to this Notice.

(3) Section 7(d) of the Regulation

The minimum amount of the spectrum utilization fee for the purpose of section 7(d) of the Regulation shall be HK\$0.

In this Notice, unless the context otherwise requires, words and expressions herein shall have the meaning assigned to them in the Ordinance and in the Regulation. This Notice shall become effective from the date hereof and shall continue in force until withdrawn, modified or replaced by the Secretary.
