Declaration of Applicant

We have read and agreed to be bound by the provisions of the “Introductory Notes for Applications under the Subsidy Scheme to Support Upgrading of Satellite Master Antenna Television (“SMATV”) Systems” and would like to apply for a subsidy of HK\$20,000 under the captioned Subsidy Scheme. We hereby declare and represent to the Office of the Communications Authority (“OFCA”) that:

- (a) we are the sole owner of the System*/ appointed applicant under the Letter of Consent* (delete wherever it is appropriate) and are authorised by the owner to submit this application;
- (b) we are the local contact person possesses all delegated powers to answer any questions that OFCA may have relating to this application;
- (c) we shall only use the subsidy to subsidise a one-off upgrade the System to enable the co-existence of the System and the fifth generation mobile (“5G”) systems, and understand that the subsidy is not intended to cover recurrent expenses such as maintenance or repair;

- (f) OFCA is entitled to and may rely on all of the declarations and representations made by the parties under the Letter of Consent in providing and administering the captioned subsidy scheme.

- (b) a copy of the valid SMATV contract entered with the SMATV contractor regarding the maintenance/leasing of the concerned system.
