3G ''Open Network'' Regulatory Framework

Industry Workshop - Invitation

The Office of the Telecommunications Authority (OFTA) will conduct a one-day industry workshop on "open network" regulatory framework for the third generation (3G) mobile services on Friday, 5 January 2001 at the Hong Kong Convention and Exhibition Centre. Details of the programme are given in the attached leaflet.

In the second consultation paper on the licensing framework for 3G mobile services issued by OFTA on 3 October 2000, the Telecommunications Authority (TA) proposed a "hybrid" approach for the selection of licensees for the operation of 3G services including, among others, the element of "open network" requirement. Responses to the second consultation paper generally called for more clarity in the "open network" regulatory framework and how the "open network" requirement should be defined and enforced. Today, OFTA issues a discussion paper entitled ""Open Network" Regulatory Framework for Third Generation Public Mobile Radio Services in Hong Kong", giving more details of the TA's proposals on the 3G "open network" regulatory framework. The purpose of the workshop is to facilitate discussions with and invite views from the industry and other interested parties on the proposals outlined in the discussion paper so as to enable the TA to finalize the "open network" regulatory framework for the 3G services.
