AUCTION OF RADIO SPECTRUM IN THE 2.5/2.6 GHz BAND FOR THE PROVISION OF PUBLIC MOBILE SERVICES

SUCCESSFUL BIDDER NOTICE

This is a notice referred to in paragraph 5.5.1 of the notice of the terms and conditions of the Auction (the "Notice") dated 4 July 2025 for the auction in relation to the use of the frequency blocks in the 2.5/2.6 GHz Band issued by the Communications Authority (the "Authority") in exercise of the powers conferred by section 32I of the Telecommunications Ordinance, the Telecommunications (Method for Determining Spectrum Utilization Fee) (Spectrum for Auction) Regulation and all other powers enabling it to specify the terms and conditions of the Auction and the payment of Spectrum Utilization Fees. Unless otherwise stated or the context otherwise requires, words and expressions used in this notice have the same meaning as that given to them in the Notice.

- 2. Pursuant to paragraphs 4.14.2 and 5.1.1 of the Notice, each of the Provisional Successful Bidders, namely China Mobile Hong Kong Company Limited, Genius Brand Limited and SmarTone Mobile Communications Limited, has notified the Authority that
 - (a) it is not a Connected Bidder in relation to another Provisional Successful Bidder; and
 - (b) it is not subject to an Approval.
- 3. Pursuant to paragraph 5.3.1 of the Notice, the Provisional Successful Bidder of each of the Frequency Blocks A1 to A5, namely China Mobile Hong Kong Company Limited, Genius Brand Limited and SmarTone Mobile Communications Limited, has provided to the Authority a Letter of Credit in full amount of the Spectrum Utilization Fee payable by it from a Qualifying Bank to guarantee payment of the Spectrum Utilization Fee on or before 31 March 2028.

4. The Authority is pleased to announce that the Successful Bidders of the Auction and the Frequency Blocks assigned to them are as follows –

The Authority will grant a licence to each Successful Bidder for the relevant Frequency Block(s) in due course upon the payment to the Authority of Spectrum Utilization Fee and where applicable, the provision of a Performance Bond for network and service rollout requirement by the Successful Bidder in accordance with relevant requirements set out in the Notice.
