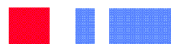

FOREWORD

1. This specification stipulates the minimum performance requirements for enhanced group call (EGC) equipment and for INMARSAT Standard-C ship earth stations (SES) capable of transmitting and receiving direct-printing communications, as required by the 1988 amendments to the 1974 International Convention for Safety of Life at Sea (SOLAS) on the introduction of the Global Maritime Distress and Safety System (GMDSS).
2. Under the Merchant Shipping (Safety) (GMDSS Radio Installations) Regulation (hereafter referred to as the Regulation) under section 37 and 107 of the Merchant Shipping (Safety) Ordinance (Cap. 369), every GMDSS equipment required to be provided under the Regulation --
 - a) shall conform to the relevant performance standards adopted by the International Maritime Organization (IMO); and
 - b) shall, in the case of equipment provided on Hong Kong ships, in addition, conform to appropriate performance specifications issued by the Telecommunications Authority (TA).
3. Under the provision of the Regulation, EGC equipment and relevant Inmarsat-C installations equipped in Hong Kong ships shall comply with this specification.
4. Type-approval of the equipment will be granted on the basis of satisfactory document evaluation of the certification issued by competent overseas authorities for the equipment. Where applicable, the application should list all type-numbers that apply to non-technical variants of the model submitted.
5. Manufacturers or their specified agents, who wish to submit their EGC and SES equipment for type-approval, shall apply to :

6. The TA may amend any part of this specification as and when he deems necessary.
7. The TA reserves the right to conduct tests or evaluations on models he considers to be technical variants and whose performance may differ as between models.
8. In case of doubt about the interpretation of this specification, the methods of carrying out the test and the validity of statements made by the manufacturers of the equipment, the decision of the TA shall be final.

1. SCOPE OF SPECIFICATION

This specification stipulates the minimum performance requirements for enhanced group call (EGC) equipment and for INMARSAT Standard-C ship earth stations (SES) capable of transmitting and receiving direct-printing communications, as required by the 1988 amendments to the 1974 International Convention for Safety of Life at Sea (SOLAS) for the introduction of the Global Maritime Distress and Safety System (GMDSS).

Equipment which comply with this specification shall be required to meet all relevant performance standards adopted by the relevant IMO Resolutions and technical characteristics as defined in the relevant ITU's Radio Regulations and Recommendations for the concerned equipment.

This specification is applicable to the following classes of equipment:

Class 0 : An EGC receiver, either stand-alone or an element of a GMDSS installation when added to an INMARSAT-A ship earth station installed in accordance with the INMARSAT design and installation guidelines (DIGs) for GMDSS installations.

Class 1 : A basic ship earth station providing shore-to-ship and ship-to-shore message transfer only.

Class 2 : As Class 1 but with EGC as an alternative to shore-to-ship transfer using a shared receiver.

Class 3 : As Class 1 but with EGC using an independent receiver.

2. TECHNICAL REQUIREMENTS

2.1 Enhanced Group Call (EGC) equipment shall comply with the basic technical requirements as defined in :-

IMO Resolution A.664(16) on "Performance Standards for Enhanced Group Call Equipment".

2.2 INMARSAT Standard-C ship earth stations (SES) capable of transmitting and receiving direct-printing communications shall comply with the basic technical requirements as defined in :-

(a) IMO Resolution A.807(19) on "Performance Standards for INMARSAT-C Ship Earth Stations capable of Transmitting and Receiving Direct-printing Communications" for equipment installed on or after 23 November 1996; or

(b) IMO Resolution A.663(16) on the same subject for equipment installed before 23 November 1996.

3. EVALUATION REQUIREMENTS

EGC equipment and INMARSAT-C SES capable of transmitting and receiving direct-printing communications shall be evaluated in accordance with the following technical standards :

- (a) IEC 1097-4 : Global Maritime Distress and Safety System (GMDSS) - Part 4 : INMARSAT-C ship earth station and INMARSAT enhanced group call (EGC) equipment - Operational and performance requirements, methods of testing and required test results, published by the International Electrotechnical Commission (IEC) ; or
- (b) ETS 300 460 : Satellite Earth Stations and Systems (SES); Maritime Mobile Earth Stations (MMESs) operating in the 1.5/1.6 GHz bands providing Low Bit Rate Data Communications (LBRDCs) for the Global Maritime Distress and Safety System (GMDSS): Technical characteristics and methods of measurement ,published by the European Telecommunications Standards Institute (ETSI).
