# Amendment to Exchange Co-location and Local Access Link Agreement ("the LAL Agreement") between and

The LAL Agreement is amended as follows:

#### 1. Definitions

1.1 The definition of "LAL" is deleted in its entirety and replaced by the following new definition:

"LAL" means a Basic Grade LAL and a Premium Grade LAL.

1.2 The definition of Voice Grade LAL is deleted in its entirety and replaced by the following new definition:

"Basic Grade LAL" means a 2-wire copper line owned by the LAL Provider between the Exchange End Equipment and a Customer Interface Point that:

- (a) will meet the specification in Clauses 1.1, 1.2, and 1.3 (as amended by Clause 2.1 of this Amendment) of Schedule 1;
- (b) may, but is not guaranteed to, provide a transmission bandwidth of 300 Hz to 50,000 Hz; and

Each reference in the LAL Agreement to "Voice Grade LAL" is deleted in its entirety and replaced with the following: "Basic Grade LAL".

1.3 The definition of Data Grade LAL is deleted in its entirety and replaced by the following new definition:

"Premium Grade LAL" means a 2-wire copper line owned by the LAL Provider between the Exchange End Equipment and a Customer Interface Point that will meet but not exceed the specifications in Clauses 2.1, 2.2 and 2.3 (as amended by Clause 2.1 of this Amendment) of Schedule 1.

Each reference in the LAL Agreement to "Data Grade LAL" is deleted in its entirety and replaced with the following: "Premium Grade LAL".

### 2. Use Of LAL and Colocation Equipment

2.1 Paragraphs 1.3 and 2.3 of Schedule 1 are deleted and replaced by the following new paragraph:

The Agreed Use for a Basic Grade LAL and a Premium Grade LAL and the operation of the associated Colocation Equipment in relation to that LAL will be the carriage of telecommunications services from 300 Hz to 50,000 Hz that are supplied under the LAL Requester's Licence over its Network.

2.2 The following new clause 13.6 is inserted after clause 13.5:

The LAL Provider may not install any conditioning device which will have the effect of lowering the bandwidth of LAL to a level of below 50,000 Hz.

# 3. Schedule 4 - Charges Schedule

The following Charges are inserted into Schedule 4 and where applicable and replace the corresponding existing Charges in Schedule 4:

#### 3.1 LAL Connection Charge and LAL Periodic Charge

The two tables in Paragraph 8.1 are replaced by the following table:
