**RE: Direct Interconnection between**

We write to confirm our previous discussions regarding the direct interconnection for voice mobile traffic between the networks of

provided that there are live traffic in between the aforesaid networks. The parties have agreed to set forth in this letter the basic terms and conditions of such interconnection arrangement prior to the finalisation of a formal direct interconnection agreement (the "Formal Agreement"). Based on the following understandings and commitments, the parties agree to set up the aforesaid direct interconnections with immediate effect:

1. shall jointly use their best endeavours to arrange one T3 transmission circuit at their own costs to connect their respective networks with the networks of each of and start sending outgoing voice traffic to via their respective direct interconnections with no later than (the "Targeted Date"). However, if the said T3 transmission circuit is not available by , the Targeted Date shall be extended to a date as shall be reasonably agreed by all the parties (the "Extended Date").
2. shall jointly use their best endeavours to arrange one T3 transmission circuit at their own costs to connect their respective networks with the networks of each of and start sending outgoing voice traffic to via their respective direct interconnections with no later than the

Targeted Date. However, if the said T3 transmission circuit is not available by , the Targeted Date shall be extended to the Extended Date.

3. Each of as the traffic receiving party shall arrange sufficient switch capacity for the purpose of terminating all incoming voice calls from sent via the T3 transmission circuit referred to in point no. 2 above.
4. Each of as the traffic receiving party shall arrange sufficient switch capacity for the purpose of terminating all incoming voice calls from sent via the T3 transmission circuit referred to in point no. 1 above.
5. shall agree on the technical configurations of the aforesaid direct interconnections and such technical configurations shall be set out in the Formal Agreement.
6. No charges shall be payable by each of to under this direct interconnection arrangement for the interconnection traffic minutes.
7. No charges shall be payable by each of to under this direct interconnection arrangement for the interconnection traffic minutes.
8. The term for the interconnection shall be 24 months from the date any of starts sending outgoing voice traffic to any other party via its direct interconnection with such other party, whichever is the earliest.
9. As this direct interconnection arrangement will enable each party to save PNETS charges, each party shall endeavour to route all its outgoing voice traffic to the others by way of this direct interconnection arrangement instead of via fixed networks.
10. The parties agree to use their reasonable endeavours to execute the Formal Agreement within from the date of this letter which agreement shall contain the terms set out herein as well as other customary terms and conditions of an interconnection agreement.
11. This letter constitutes a legal binding agreement between the parties ("Letter Agreement") and shall only cease to have legal force and effect upon the execution of the Formal Agreement. The terms herein shall be governed by the laws of the Hong Kong Special Administrative Region of the People's Republic of China.
