NEW SCHEDULE 1C OF POI ESTABLISHMENT AGREEMENT

INTERCONNECT LINK (IN T1)

Part I: General

and agree on <u>1st August 1997</u> (the "Effective Date") to replace the original Schedule 1C of the POI Establishment Agreement dated 29th June 1995 (the "POI Agreement") with this New Schedule 1C.

This New Schedule 1C will apply for the capacity increase up to 168 T1, including 84 T1 that has already ordered under the original Schedule 1C.

Switch Location

Interconnect Gateway Exchange

The parties will negotiate in good faith and agree on which Interconnect Gateway Exchanges the Interconnect Links will be provisioned for from time to time.

Provisioning Date

A maximum provision of capacity of 84 T1s will be provided on a date which is no less than 7 months from the Effective Date of this New Schedule 1C.

Prior to the Provisioning Date specified above, T1 in accordance with the original Schedule 1C.

Minimum Service Period

Minimum Required Capacity

The minimum capacity which must be ordered by in respect of Interconnect Equipment and capacity on Network is 112 T1 (including the 84 T1 that has already ordered in accordance with the original Schedule 1C).

Growth Conditions

- 1. Additional capacity may be ordered under the POI Agreement in accordance with this New Schedule 1C, up to a maximum of 168 T1 (including 84 T1 that has already ordered in accordance with the original Schedule 1C), in minimum blocks of 4 T1 respectively.
