1. DEFINITIONS AND INTERPRETATIONS

"Initial Term" means the period from the Effective Date to 30 June 2024 (both dates inclusive).

(d) Clause 8 be deleted and replaced by the following:

#### 8. EFFECTIVE DATE AND TERM

- 8.1 Unless otherwise terminated earlier in accordance with this Agreement, this Agreement shall come into force on the Effective Date and shall continue in full force and effect for the Initial Term.
- 8.2 Upon expiry of the Initial Term, this Agreement shall automatically continue unless either Party terminates this Agreement by giving the other Party ninety (90) days prior written notice.

### 3. FULL FORCE AND EFFECT

- (a) This Amendment Agreement shall take retrospective effect from 1 July 2019. ("Amendment Effective Date"). All rights and obligations accrued before Amendment Effective Date shall not be affected by this Amendment Agreement.
- (b) Save for the amendments set out in Amendment Agreement, all the terms and conditions of the Agreement shall remain in full force and effect.
- (c) In the event of any conflict or inconsistency between the provisions of this Amendment Agreement and the Agreement, the provisions of this Amendment Agreement shall prevail to the extent of such inconsistency.

#### 4. GOVERNING LAW AND JURISDICTION

This Amendment Agreement shall be construed and interpreted in accordance with the laws of Hong Kong and the Parties agree to irrevocably and unconditionally submit to the exclusive jurisdiction of the courts of Hong Kong in relation to any disputes, controversies and differences arising from this Amendment Agreement.
