MOBILE CARRIER LICENCE TELECOMMUNICATIONS ORDINANCE (Chapter 106)

Description of Tariff

Interconnection Charges ("Charges") for Fixed Telecommunications Network Services Licences, Fixed Carrier Licences and Unified Carrier Licences under which the scope of service is for the provision of fixed telecommunications services (herein below referred as "Fixed Network Operators")

1. Fixed Network Operators who are directly connected to the network of SmarTone Mobile Communications Limited ("SmarTone") shall pay the following Charges to SmarTone as applicable:

Type of Calls	Charges
(a) Incoming external telecommunication calls terminated on SmarTone network	15 cents per occupancy minute
(b) Outgoing external telecommunication calls originated from SmarTone network	15 cents per occupancy minute
(c) For all local calls originated from Fixed Network Operators network and terminated on SmarTone network	15 cents per occupancy minute

2. Fixed Network Operators who are not directly connected to the SmarTone network shall pay the following Charges to SmarTone as applicable:

Type of Calls	Charges
(a) Incoming external telecommunication calls terminated on SmarTone network	15 cents per occupancy minute
(b) Outgoing external telecommunication calls originated from SmarTone network	15 cents per occupancy minute
(c) For all local calls originated from Fixed Network Operators network and terminated on SmarTone network	15 cents per occupancy minute

3. Special Conditions

- 3.1 The Charges listed above shall apply unless there is any applicable interconnection or relevant agreement between SmarTone and the Fixed Network Operator concerned.
- 3.2 The Charges provided do not include any applicable line charges or any international calls charges or any Universal Service Contribution charges or other charges as indicated.
- 3.3 Occupancy minute means the time measured over the interconnection line or circuit between the seizure of a circuit and the release of the circuit.
- 3.4 The Charges are applicable to all calls to or from the Fixed Network Operator network irrespective of whether the Fixed Network Operator is directly or indirectly connected to the SmarTone network.
- 3.5 SmarTone may vary any terms, conditions or rates of this tariff from time to time by publication in the newspaper, or by notification to the Telecommunications Authority, or by notification to the Fixed Network Operators, or using other reasonable notification methods.
- 3.6 The Charges are subject to SmarTone's General Terms and Conditions (T&C 01) where applicable. If any term of these Special Conditions is inconsistent with the General Terms and Conditions, these Special Conditions will prevail.
