

**AUCTION OF RADIO SPECTRUM
IN THE 2.5/2.6 GHz BAND
FOR THE PROVISION OF PUBLIC MOBILE SERVICES**

PROVISIONAL SUCCESSFUL BIDDER NOTICE

This is a notice referred to in paragraph 4.14.1 of the notice of the terms and conditions of the Auction (the “Notice”) dated 4 July 2025 for the auction in relation to the use of the frequency blocks in the 2.5/2.6 GHz Band issued by the Communications Authority (the “Authority”) in exercise of the powers conferred by section 32I of the Telecommunications Ordinance, the Telecommunications (Method for Determining Spectrum Utilization Fee) (Spectrum for Auction) Regulation and all other powers enabling it to specify the terms and conditions of the Auction and the payment of Spectrum Utilization Fees. Unless otherwise stated or the context otherwise requires, words and expressions used in this notice have the same meaning as that given to them in the Notice.

2. The Authority would like to announce that the Bidding Stage of the Auction has been completed today (20 October 2025). The result of the Bidding Stage is set out below –

3. Pursuant to paragraphs 4.14.2 and 5.1.1 of the Notice, each of the Provisional Successful Bidders is required to within two Business Days after the date of this Provisional Successful Bidder Notice, notify the Authority –

- (a) whether it is a Connected Bidder in relation to another Provisional Successful Bidder by completing and submitting the Connected Bidder Statutory Declaration (the form of which is given in Appendix 7 of the Notice); and
- (b) whether it is subject to an Approval and if so, the details of that Approval.

4. Pursuant to paragraph 5.3.1 of the Notice, the Provisional Successful Bidder of each of the Frequency Blocks A1 to A5 in the table of paragraph 2 is required to within 35 Business Days after the date of this Provisional Successful Bidder Notice, provide to the Authority a Letter of Credit in full amount of the Spectrum Utilization Fee payable by it from a Qualifying Bank to guarantee payment of the Spectrum Utilization Fee on or before 31 March 2028.
