

UNIFIED CARRIER LICENCE
TELECOMMUNICATIONS ORDINANCE (CHAPTER 106)

Hong Kong Telecommunications (HKT) Limited

Mobile Interconnection Services Tariff (“Tariff”)

1. This Tariff is offered by the mobile entity under Hong Kong Telecommunications (HKT) Limited (“**PCCW Mobile**”).
2. This Tariff applies to the holder of a Fixed Telecommunications Network Services Licence, Fixed Carrier Licence or Unified Carrier Licence who provides fixed telecommunications services including local and/or external calls (“**Fixed Telecommunications Licensee**”).
3. Any Fixed Telecommunications Licensee who directly or indirectly passes or receives traffic of the types specified in clause 5 below with PCCW Mobile shall be deemed to have accepted this Tariff.
4. If there is an applicable interconnection contract or other relevant agreement between PCCW Mobile and the Fixed Telecommunications Licensee concerned then this Tariff shall not apply.

Charges

5. The following charges shall be payable by the Fixed Telecommunications Licensee to PCCW Mobile from the effective date of this Tariff:

Local Call Termination Local calls originating from the Fixed Telecommunications Licensee’s network and terminating on PCCW Mobile’s network regardless of whether or not the Fixed Telecommunications Licensee’s network is directly or indirectly connected to PCCW Mobile’s network	HK\$0.30

Type of Call	Charge per Occupancy Minute
External Call Origination & Termination	
(i) Outgoing external telecommunication calls originating from PCCW Mobile's network and routed via the Fixed Telecommunications Licensee's network regardless of whether or not the Fixed Telecommunications Licensee's network is directly or indirectly connected to PCCW Mobile's network	HK\$0.30
(ii) Incoming external telecommunications calls routed via the Fixed Telecommunications Licensee's network and terminating on PCCW Mobile's network regardless of whether or not the Fixed Telecommunications Licensee's network is directly or indirectly connected to PCCW Mobile's network	HK\$0.30

6. In addition, should the Fixed Telecommunications Licensee seek to impose charges on PCCW Mobile for local call termination or external call origination and termination in accordance with its own tariff prior to the effective date of this Tariff, PCCW Mobile has the right to impose, on a reciprocal basis, the same terms, conditions and rates on the Fixed Telecommunications Licensee as those contained in the Fixed Telecommunications Licensee's tariff in respect of traffic for the period concerned.

Alternatively, should the Fixed Telecommunications Licensee be affiliated with the holder of a Mobile Carrier Licence or Unified Carrier Licence providing mobile telecommunications services ("**Affiliated Mobile Telecommunications Licensee**") and that Affiliated Mobile Telecommunications licensee has imposed charges on Hong Kong Telecommunications (HKT) Limited for local call termination or external call origination and termination in accordance with its own tariff prior to the effective date of this Tariff, PCCW Mobile has the right to impose the same terms, conditions and rates on the Fixed Telecommunications Licensee as those contained in the tariff of its Affiliated Mobile Telecommunications Licensee in respect of traffic for the period concerned.

Payment

7. PCCW Mobile shall invoice the Fixed Telecommunications Licensee for the charges on a monthly basis.
8. The Fixed Telecommunications Licensee shall settle the invoices within 30 days from the date of the invoice ("**Due Date**") in full without set-off or counter-claim and free and clear of any withholding or deduction.
9. If the invoice is not settled by the Fixed Telecommunications Licensee by the Due Date, PCCW Mobile may charge interest on the amount outstanding at a rate of 2%

per annum over the prevailing best lending rate for Hong Kong Dollars offered by the Hongkong & Shanghai Banking Corporation in Hong Kong.

Terms & Conditions

10. Any terms and conditions not specified in this Tariff shall be covered by PCCW Mobile's General Conditions of Service.
11. PCCW Mobile may vary the terms, conditions and rates contained within this Tariff at any time.

Effective Date of Tariff

12. This Tariff is effective from 15 October 2009.
