- [X].5 If the Authority carries out an audit of the licensee's Accounts pursuant to Special Condition [] in respect of a Royalty Year, the licensee shall not be relieved of its obligation to pay the Spectrum Utilization Fees in accordance with paragraph [X].2 in respect of that Royalty Year. If, as a result of that audit, the Spectrum Utilization Fees in respect of that Royalty Year is:

(for the purpose of calculation of the Appropriate Fee, the spectrum assigned for use by the licensee shall be, in respect of each Royalty Year, the spectrum assigned for use by the licensee on 30 September of the Royalty Year); and

"Royalty Year" means each period of 12 months beginning with 30 September from 30 September 2011 to 29 September 2021.
