This is a notice referred to in paragraph 5.5.1 of the notice of the terms and conditions of the Auction (the "Notice") dated 30 July 2021 issued by the Communications Authority (the "Authority") in exercise of the powers conferred by section 32I of the Telecommunications Ordinance, the Telecommunications (Method for Determining Spectrum Utilization Fee) (Spectrum for Auction) Regulation and all other powers enabling it to specify the terms and conditions of the Auction and the payment of Spectrum Utilization Fees. Unless otherwise stated or the context otherwise requires, words and expressions used in this notice have the same meaning as that given to them in the Notice.

- 2. Pursuant to paragraphs 4.14.2 and 5.1.1 of the Notice, each of the Provisional Successful Bidders, namely China Mobile Hong Kong Company Limited, Hong Kong Telecommunications (HKT) Limited, Hutchison Telephone Company Limited and SmarTone Mobile Communications Limited, has notified the Authority that -
 - (a) it is not a Connected Bidder in relation to another Provisional Successful Bidder; and
 - (b) it is not subject to an Approval.
- 3. Pursuant to paragraphs 5.3.1 of the Notice -
 - (a) the Provisional Successful Bidder of each of the Frequency Blocks B1 to B7, namely China Mobile Hong Kong Company Limited, Hong Kong Telecommunications (HKT) Limited, Hutchison Telephone Company Limited and SmarTone Mobile Communications Limited, has provided to the Authority a one-year recurring Letter of Credit in full amount of the

Spectrum Utilization Fee payable by it from a Qualifying Bank to guarantee payment of the Spectrum Utilization Fee until payment of the Spectrum Utilization Fee is made upon notification by the Authority when the actual date for assignment of the Frequency Blocks B1 to B7 is fixed;

- (b) the Provisional Successful Bidder of Frequency Block C, namely SmarTone Mobile Communications Limited, has
 - (i) paid the Authority the Spectrum Utilization Fee payable by it; and
 - (ii) provided to the Authority a Performance Bond for network and service rollout requirement in accordance with the Conditions;
- (c) the Provisional Successful Bidder of each of the Frequency Blocks D1 to D9, namely China Mobile Hong Kong Company Limited, Hong Kong Telecommunications (HKT) Limited and Hutchison Telephone Company Limited, has provided to the Authority a Letter of Credit from a Qualifying Bank to guarantee payment of the Spectrum Utilization Fee payable by it on or before 31 January 2024;
- (d) the Provisional Successful Bidder of each of the Frequency Blocks E1 to E2, namely China Mobile Hong Kong Company Limited and SmarTone Mobile Communications Limited, has
 - (i) paid the Authority the Spectrum Utilization Fee payable by it; and
 - (ii) provided to the Authority a Performance Bond for network and service rollout requirement in accordance with the Conditions or an undertaking to guarantee its compliance with the network and service rollout requirement in lieu of a Performance Bond, where applicable.
